THAT the Town of Barkmere thanks Mr Michel Trudel for his excellent work as Town Manager of Barkmere during the past four (4) years.

4.3 Human Resources

4.3.1 Resolution 2011-10: Appointment of an assistant clerk

Considering that Mrs Caroline Dion was hired as Director General of the Town of Barkmere;

Considering that Mr Robert Mearns is the secretary-treasurer of the municipality;

Considering that Mr Mearns will cease office not later than June 30th 2011 and Mrs Dion will replace him;

Considering that article 96 of the *Cities and Towns Act* allows the Town to appoint an assistant clerk;

Considering it is necessary during this period in order to facilitate the transition, to appoint Mrs Dion assistant-clerk;

Therefore, Councillor France Boucher, Councillor Marc Fredette seconded, and it was unanimously resolved by all present:

That the Town of Barkmere appoints Mrs Caroline Dion as assistant clerk.

4.3.2 <u>Resolution 2011-11: Appointment of the person in charge of access to documents</u> of the municipality

Considering the hiring of Mrs Caroline Dion as Director General and her appointment as assistant-clerk;

Considering that section 114.2 of the City and Town Act provides the powers and duties of the person in charge of access to documents of the municipality;

Considering that it is necessary to appoint Mrs Dion the person in charge of access to documents of the municipality

Therefore, Councillor Stephen Lloyd moved, Councillor Jake Chadwick seconded, and it was unanimously resolved by all present:

That the Town of Barkmere appoints Mrs Caroline Dion as the person in charge of access to documents of the municipality with all the powers and duties vested by law.

4.3.3 <u>Resolution 2011-12: Appointment of as designated officer under the Permits and</u> <u>Certificates bylaw no. 204</u>

Considering the hiring of Mrs Caroline Dion as Director General;

Considering that sections 1.2.2 and 1.2.3 of the Permits and Certificates Bylaw no 204 provides the powers and duties of the designated officer for the enforcement of the said bylaw;

Considering that it is necessary to appoint Mrs Dion as a designated officer in accordance to the Permits and Certificates Bylaw no 204 with all the powers and duties provided for therein;

Therefore, Councillor Laurent Barbé moved, Councillor Jean Dubois seconded, and it was unanimously resolved by all present:

That the Town of Barkmere appoints Mrs Caroline Dion as a designated officer in accordance to the Permits and Certificates Bylaw no 204 with all the powers and duties provided for therein.

4.4 Procurement

4.4.1 Resolution 2011-14: Computer purchase

Considering that one of the Town computer his outdated and needs to be replaced;

Considering the usefulness of a laptop computer for the Director General;

Therefore, Councillor Stephen Lloyd moved, Councillor Jean Dubois seconded, and it was unanimously resolved by all present:

That the Town of Barkmere buys a laptop computer for the use of the town manager;

That the total expenditures for the purchase of that computer do not exceed \$1,000, plus taxes.

4.5 Contract

Mayor Luc Trépanier explains that the Town was asked by a resident interested in buying a lot which would allow to resolve some security issues on chemin Barkmere and to improve the supply of services to the population. The Town wishes to have this lot evaluated.

4.5.1 Resolution 2011-15: Contract grant to Évaluations Serge Lavoie Inc.

Considering that the Town of Barkmere was approached for the purchase of a vacant land located on lots 2-118 et 2-119 of the cadastre of the township of Arundel, registration division of Argenteuil (172, chemin Barkmere)

Considering that it is necessary to carry out the assessment of the land;

Considering the proposition of Évaluations Serge Lavoie Inc to provide an assessment report for the amount of 700\$, excluding the applicable taxes;

Therefore, Councillor Marc Fredette moved, Councillor Laurent Barbé seconded, and it was unanimously resolved by all present:

That the Town of Barkmere grants a contract to Évaluations Serge Lavoie Inc to provide an assessment report for the lots 2-118 and 2-119 of the cadastre of the township of Arundel, registration division of Argenteuil (172, chemin Barkmere);

That the total expenditures for the assessment report does not exceed \$700, plus taxes.

6. <u>Urbanism</u>

6.1 <u>Parks</u>

Councillor Jean Dubois explains the results of the survey. Following the suggestions received, he notes that the wishes of the residents are greater than what was originally.

6.1.1 Resolution 2011-17: Brian Clarke Memorial

Considering that J. Brian Clarke was Mayor of Barkmere on two occasions, for a total of 15 years;

Considering that a group of citizens suggested to erect a memorial to honour his memory, to acknowledge his contribution and devotion to the Town of Barkmere;

Therefore, Councillor Laurent Barbé moved, Councillor Jean Dubois seconded, and it was unanimously resolved by all present:

That the Town of Barkmere erects a monument to the memory of former Mayor J. Brian Clarke, in the form of a stone bench bearing a dedicated bronze plaque;

That the total expenditures to erect this monument do not exceed \$1,100, taxes included.

ADOPTED

7. Public Services

7.1 Public Security

7.1.1 Resolution 2011-18: Marine Equipment Purchase

Considering that a LED marine light of a buoy located on Bark Lake, in the Narrows sector, is damaged;

Considering that the LED marine lights are powered by solar energy and batteries;

Considering that the LED marine light's batteries lifetime expires shortly;

Considering it is essential to ensure the safety of the users of the Lake that the damaged LED marine light and the batteries of all buoys must be replaced

Therefore, Councillor Stephen Lloyd moved, Councillor Jake Chadwick seconded, and it was unanimously resolved by all present:

That the Town of Barkmere buys a LED marine light and replacement batteries;

That the total expenditures for the purchase of the marine equipment does not exceed \$1,000, plus taxes.

ADOPTED

7.2 Waste management

Mayor Luc Trépanier mentions that the RCM of Laurentides has granted a three-year contract for the garbage collection, which represents a decrease of costs of close to 23% for the Town of Barkmere. This contract will take effect as of July 1st 2011, therefore these savings will be reflected on the 2012 taxes only.

7.3 <u>Telecommunications</u>

Mayor Luc Trépanier explains the new policy on the Internet services of the RCM of

Laurentides, aiming to ensure the control and the management of their information technology. The Town of Barkmere must comply with this policy, and take measures to limit the access to the Internet network of the RCM. For the moment, the access will be limited by the grant of a temporary password, on request only, upon presentation of a proof of residence, while visiting the public buildings. The passwords will be changed periodically.

7.3.1 <u>Resolution 2011-19: Access restriction to the wireless Internet network of the</u> <u>municipality</u>

Considering that the Town of Barkmere is served by an Internet network provided by the MRC des Laurentides;

Considering that the MRC des Laurentides has adopted a policy for the use of its IT services at the Mayors meeting of November 2010, and that the Town of Barkmere must comply;

Considering that the Town of Barkmere can and wishes to provide its residents with a temporary access to its wireless Internet network within the municipality buildings;

Considering that the Town of Barkmere wishes to restrict access to its wireless Internet network within the municipal buildings only

Therefore, Councillor Laurent Barbé moved, Councillor Jake Chadwick seconded, and it was unanimously resolved by all present:

That the Town of Barkmere restricts access to its wireless Internet network on proof of residence by the citizen, only for temporary access within the buildings of the municipality.

8. RCM and Governmental business

8.1 Mayor's Report

Mayor Luc Trépanier presents a summary of the discussions arising from the meeting of the Mayors Council of the RCM, held in January. In particular, he talks about the modification to the declaration of competency of the RCM, regarding waste management, to allow three (3) municipalities to withdraw in order to create their own inter-municipal administration.

8.2 <u>Resolution 2011-20: Agreement protocol renewal; with Transport adapté et collectif</u> <u>des Laurentides (TA&CL)</u>

Considering that it is necessary to renew the agreement protocol with "Transport Adapté et Collectif des Laurentides" for the provision, in the territory of the Town of Barkmere for 2011, for door to door para-transit services for persons with disabilities;

Therefore, Councillor France Boucher moved, Councillor Jean Dubois seconded, and it was unanimously resolved by all present:

That the Town of Barkmere means to Transport adapté et collectif des Laurentides (TA&CL) its acceptance of the agreement protocol renewal for para-transit services for persons with disabilities

That the Town of Barkmere pays its municipal share of the sum of \$241,86 (\$2.78 for 87 permanent residents);

That the Town of Barkmere mandate Luc Trépanier, as its representative on the Board of Directors of TA&CL and Laurent Barbé, as substitute.

ADOPTED

8.3 Resolution 2011-21: Payment to a third of the tax on 9-1-1 telephone services

Considering that the Agence municipal de financement et de développement des centres d'urgence 9-1-1 du Québec was created in accordance with sections 244.73 and 244.74 of the Act respecting municipal taxation and must remit the tax levied for the telephone services to local municipalities for the funding of the 9-1-1 emergency centers;

Considering that the Town of Barkmere wants the Agence to remit directly to the body designated to provide the 9-1-1 emergency center services, as soon as possible;

Therefore, Councillor Stephen Lloyd moved, Councillor Marc Fredette seconded, and it was unanimously resolved by all present:

That the Town of Barkmere directs the Agence municipale de financement et de développement des centres d'urgence 9-1-1 du Québec to pay, as promptly as possible, to the Town of Mont-Tremblant, for and on behalf of the Town of Barkmere, all tax proceeds collected under article 244.68 of the Act respecting Municipal Taxation and which are otherwise due to the Town of Barkmere, the Town of Barkmere effectively acknowledging receipt of same, with such direction to have effect for so long as the Agence has not received 60 days' prior notice of a change in payee, the whole subject to the obligation of the Agence to render account to the Town of Barkmere of such payments.

ADOPTED

8.4 <u>Resolution 2011-22: Grant for the improvement of Jesuit Road and Duncan Road</u> <u>East and West</u>

Considering that the Town of Barkmere was granted an amount of \$10,000 from the Ministry of Transportation of Quebec for the improvement of Jesuit Road, and Duncan Road East and West;

Considering that the works have completed;

Considering that the expenditures to improve said roads are in the order of \$27,000, before taxes;

Councillor Laurent Barbé moved, Councillor Jake Chadwick seconded and it was unanimously resolved by all present:

That the Town of Barkmere approves the expenditures for the improvement works executed on said roads, for a subsidized amount of \$10,000, in conformity with the requirements of the Ministry of Transportation of Quebec;

That the works have been executed in conformity with the actual expenses on said roads whose management is the responsibility of the municipality, and that the audit file has been completed;

That the Town of Barkmere transmits to the Ministry of Transportation before February 15 2011 the form and the vouchers, in order to receive the grant.
