#### 3.1. Announcements

The Town would like to repeat that there will not be any containers for large garbage at the Landing for the summer season of 2015. The Town is currently organizing a pilot project for mobile eco-centers. We restate that the containers currently at the Landing must be used only for domestic garbage and allowable recyclable materials. The Town will be more severe on this point.

Citizens are throwing out electronic garbage and construction materials in the containers at the Landing. This causes considerable administrative complications and extra fees charged to the Town. We ask for the collaboration of everyone and remind you that citizens have access to eco-centers to dispose of this residual matter. Entrepreneurs must make arrangements to get rid of their construction materials and pay the necessary fees for such.

## 5.2 <u>Resolution 2015-041 – Authorization of a Request For Tender (RFT) for professional services in the file of rebuilding the Town Hall</u>

WHEREAS the resolution 2013-114;

**WHEREAS** the letter from the "Ministère des Affaires municipales et de l'Occupation du territoire (MAMOT)" received on September 25th, 2014 gave the Town a preliminary authorization for the "Programme d'infrastructures Québec-Municipalités (PIQM)";

WHEREAS the requirements letter from the MAMOT received on October 10th, 2014;

**WHEREAS** this letter gave a list of requirements that the Town has to follow to obtain a definitive authorization for the grant awarded;

**WHEREAS** THAT the Town needs professional services of an architect quickly in this process in order to meet the requirements;

WHEREAS the Town will go with a Request For Tender for these services;

WHEREAS a committee must be formed before the Request For Tender;

**THEREFORE,** Councillor Tim Kalil moved, Councillor Bruce MacNab seconded, and it was unanimously resolved by all present:

**THAT** the Council of the Town of Barkmere authorize the transmission of the Request For Tender number 2015-001, following the formation of the selection committee, for professional services of an architect, with a weighting system in accordance with the article 573.1.0.1.1 of the *Cities and Towns Act*, CQLR, c. C-19, the weighting system will consist of the following critera:

- Criterion 1 Understanding the mandate Methodology (30 points)
- Criterion 2 Qualification and experience of the bidder (25 points)
- Criterion 3 Qualification and experience of project leader (25 points)
- Criterion 4 Respect of the schedule and availability to the project (20 points)

## 5.3 Resolution 2015-042 - Creation of a new path on Goulden Island

**WHEREAS** Goulden Island was bequeathed to the Town of Barkmere by the will of the late Christopher Healy Goulden and the deed from his widow Adelaide Mackenzie Mae and her daughter Edith M. Goulden, provided it is used as a park or recreation ground for all citizens and residents of Barkmere:

**WHEREAS THAT** the Town of Barkmere, in order to respect the donor's wishes, has signed a lease with the BLPA to use the northern part of Gould Island for recreation;

**WHEREAS THAT** the Town wants to work with the BLPA for the creation of a new walking path on Goulden Island;

**THEREFORE,** Councillor Chantal Raymond moved, Councillor Jake Chadwick seconded, and it was unanimously resolved by all present:

**TO AUTHORIZE** the establishment of a project to create a new walking path on Goulden Island..



#### 6. Urban Planning

#### 6.1 Resolution 2015-043 – Exemption from reading Bylaw 228 amending zoning Bylaw 201

**CONSIDERING THAT** Article 356 of the *Cities and Towns Act* (RSQ c. C-19) allows the dispensation of the reading of a draft bylaw;

**CONSIDERING THAT** a copy of the Bylaw number 228 was given to the members of the Council more that two judicial days before the current session;

**CONSIDERING THAT** all members of the Council declared having read the Bylaw number 228 and forgo its reading;

**THEREFORE,** Councillor Marc Fredette moved, Councillor Chantal Raymond seconded, and it was unanimously resolved by all present:

**THAT** the Municipal Council of the Town of Barkmere forgo the reading of Bylaw number 228 amending the zoning Bylaw number 201.

## 6.2 Resolution 2015-044 - Adoption of draft Bylaw 228 amending zoning Bylaw 201

**WHEREAS** the Regulation of zoning number 201 is in force since December 7<sup>th</sup>, 2009, the date of issuance of the certificate of conformity of the RCM of the Laurentians;

WHEREAS the municipality may, according to law, modify the contents of its bylaws;

**WHEREAS** the draft bylaw modifies regulations regarding works near streams and lakes;

**WHEREAS** the current modification aims to complete and clarify regulations already existing;

**WHEREAS** a notice of motion was given by the Councillor Stephen Lloyd on the meeting held on March 14<sup>th</sup>, 2015;

**THEREFORE,** Councillor Jake Chadwick moved, Councillor Chantal Raymond seconded, and it was unanimously resolved by all present:

TO ADOPT the draft Bylaw 228 amending zoning Bylaw 201.

## 6.3 Resolution 2015-045 – Public consultation concerning the draft Bylaw 228 amending zoning Bylaw 201

**WHEREAS** Article 53 of the Act Respecting Land use Planning and Development (RSQ, c A-19-1) states that the draft bylaws regarding urbanism must be submitted to a public consultation:

**WHEREAS** Article 53.1 of the Act Respecting Land use Planning and Development (RSQ c A-19-1) states that the public consultation must be held via a commission formed by members of the Municipal Council;

**WHEREAS** Articles 125 and 127 of the Act Respecting Land use Planning and Development (RSQ, c A-19-1);



**THEREFORE**, Councillor Jake Chadwick moved, Councillor Chantal Raymond seconded, and it was unanimously resolved by all present:

**THAT** the Municipal Council of the Town of Barkmere institutes a commission with the mandate of organizing a public consultation on the acceptance of draft Bylaw 228 and appoint the following members:

- The Mayor of the Town, Luc Trépanier;
- Councillor Stephen Lloyd;
- Councillor Jake Chadwick;

#### **AND**

**THAT** the Town of Barkmere hold a public consultation, regarding draft Bylaw 228, on Saturday May 9th, 2015, at 9:30 AM at the Community Center of Barkmere.

## 6.4 Resolution 2015-046 - Hiring of Apur firm

WHEREAS the Town adopted its urbanism bylaws in 2009;

**WHEREAS** the Town has noted that regulations have some deficiencies in their application, towards achieving the objectives and respecting the vision of the Town.

**WHEREAS** the Town wants to clarify certain regulations and facilitate the implementation of urbanism bylaws;

WHEREAS the Town received a service offer from the urbanism firm Apur;

**THEREFORE**, Councillor Marc Fredette moved, Councillor Bruce MacNab seconded, and it was unanimously resolved by all present:

**TO HIRE** the firm Apur to revise its urbanism bylaws for a maximal amount of \$6,270.00 to this amount must be added the 5% management fees; travel fees; and, taxes.

## 8.1 Mayor's Report

- a) The MRC has hired Ms. Katia Morin as Director of Legal Services and Human Resources, having met with several candidates before making a decision. There was a discussion concerning the limited resources available in small towns and cities to keep their employees.
- b) Concerning the "parc linear", there was a discussion regarding who would assume the costs of same.
- c) There was a presentation on the interactive information terminals which allowed users to view the tourist attractions of the MRC.
- d) Concerning the file on the services of the Laurentian School Commission, the MRC voted a resolution to block the relocation of school children.
- e) The RIDR invoiced an adjustment for the year 2014 and, after its division, Barkmere must pay approximately \$2,700.00. This increase is primarily due to the surplus of tonnage from last year.
- f) There was a motion to congratulate the Municipality of Lac-Tremblant-Nord because it was the highest performing municipality in regards to recycling.
