#### 3. Current Affairs

### 3.1. Announcements

We held, as scheduled, two mobile Écocentre days on the 15th and 16<sup>th</sup> of August. We want to thank Dick, Normand, Shayne and Kevin O'Shaughnessy, Robert Bell, Gabriel Paquette, Adam Johnson, Peter Kalil and Lea Hardcastle, Linda and Rene Gagnon for their volunteerism. These two days were a great success. We have collected 1000 pounds of metal and filled two containers of 40 cubic yards. In conclusion this activity will reduce landfill waste and reduce our costs.

Councillor Jake Chadwick, president of the CCE, informs us that the 2014report on the water quality of Bark Lake was deposited and a copy will be available for consultation on the website of the Town.

The Town administration informed us that preparatory work started last week in connection with the dam repairs planned for this fall.

#### Dam File:

We received an ultimatum from the Centre d'expertise hydrique du Québec to conduct dam repairs. There will be no other extension granted by the government. We held an extraordinary meeting on August 22 to plan future actions. We have mandated the firm Équipe Laurence from St-Sauveur. They will prepare plans and a quote for the dam repair and proceed by agreement with contractors for various works. The Town administration in support with the mandated firm and will manage in-house planning and execution of works. To finance this work, we will make the arrangements to obtain a grant from the TECQ.program

We received a letter from Hydro-Québec informing us of pruning work on the transmission line located at the east end of town.

# 3.4. Follow up from last meeting

Project of the Town Hall and Community Centre:

We are at the final step for the plans and specifications with the various professionals. The file project for our grant must be deposited to MAMOT for October 9th.

The Ruralys firm mandated by the Town for the research of the archaeological potential of the site chosen for the construction, confirms that the site of construction of the future municipal building represents only a small archaeological occurrence rates. We can build the Town Hall and Community Center there.

# 6.1 Notice of motion Modifications to Zoning Bylaw 201

A notice of motion is given by Councillor Stephen Lloyd, to introduce at a future meeting of the Municipal Council a draft bylaw modifying Zoning Bylaw 201.

The objective this bylaw will be to revise the allowed length, width and surface of wharves, the maximum width of wharf attachments to the shoreline, the location of wharves in respect with property lines, the definition of accessibility for exceptional case according to the depth of the shore.

This bylaw will also aim to set architectural standards for boathouses, including the number and orientation of openings and the interior configuration.

Finally, this bylaw will revise the rules relating to lighting on wharves and boathouses.

# 7.1 Mayor's report

We received an IT resource use policy from the MRC's. This policy aims to standardize and provide the users of IT equipment with a prescribed use.

Following the public tender for the PGMR, the MRC has received only one proposal: that of RC Miller for garbage collection. The submitted price is 27% higher than the current price. This increase will have a direct impact on our taxes for 2016. We will analyze options to minimize the impact of this increase in our taxes by revising the number of monthly collections during winter. We will know the real increase when the distribution of the increase will be shared between the six participating municipalities.

Régie régionale de services d'incendies : since the municipality of Labelle opteed out of the project and Lac Superior and La Minerve have been thinking of leaving it, the implementation will only be feasable for 2017. Meanwhile, the Project leaders will attempt to add other municipalities in the southern sector.

### 7.2 Resolution 2015-124 - Policy regarding the use of information technology resources
