4.2.1 <u>Resolution 2012-18 – Professional liability insurance for the lawyer at the sole</u> service of the Town of Barkmere

Considering that Ms. Dion performs exclusively for the Town of Barkmere;

Considering that under the Règlement sur la souscription obligatoire au Fonds d'assurance responsabilité professionnelle du Barreau du Québec (R.R.Q. ch. B-1, r.20), the Town has to guarantee, indemnify and save harmless Ms Dion;

4.4 Resolution 2012-20 - Town wharf rental rates for 2012

Whereas it is necessary to fix the applicable rates for the municipal rental wharf for the period of May 15, 2012 to November 1, 2012;

Whereas the applicable rate in 2011 was \$457 for regular size mooring and \$264 for a small mooring;

Whereas the contract for the rental of the docks for the town increases by 2.5% for 2012

Considering the addition of new wharfs for 2012;

Therefore, Councillor Marc Fredette moved, Councillor Stephen Lloyd seconded, and it was unanimously resolved by all present:

That the Town of Barkmere fix the applicable rates for the rental of the municipal wharfs to the residents for the period from May 15, 2012 to November 1, 2012 to the sum of \$449 for a regular sized mooring and \$247 for a small mooring;

That the wharfs be leased in priority to the residents of the Town of Barkmere;

That in cases where places are still available on May 15, 2012, the rates for non-residents for the same period are \$898 for a regular sized mooring and \$494 to a small mooring

That the Town of Barkmere authorize the Director general to sign the leases for the wharfs.

5. Urbanism

5.1 <u>Resolution 2012-12 – Term renewal of the members of the Consultative Committee on Urbanism (CCU)</u>

Considering Bylaw 205 and resolution 2010-14;

Considering that the two (2) year term of office of the members of the CCU mentioned thereafter expires;

Therefore, Councillor Stephen Lloyd moved, Councillor Bruce MacNab seconded, and it was unanimously resolved by all present:

That the term of office of the following persons appointed as members of the CCU, be renewed for a period of one (1) year starting March 10, 2012:

6. Environment

6.1 Water quality

Councillor Jake Chadwick explains that the CCE is ready to file its report on water tests done this winter and in the course of the last year. The results will form a model by our expert. Also, there will be more tests to assess levels of phosphates. About the level of fecal coliform in the Long Creek, the results show the same levels at the bridge in the Lake.

7. Public Services

7.1 Landing

7.1.1 Resolution 2012-22 - Contract for the addition of rental wharfs

Considering the lack of available municipal wharfs to rent;

Considering the current contract with Quais Laurentiens and their proposal for the addition of eight (8) other wharf spaces;

Therefore, Councillor Laurent Barbé moved, Councillor Bruce MacNab seconded, and it was unanimously resolved by all present:

That the Town of Barkmere award a contract to Quais Laurentiens to lease eight (8) additional spaces in accordance with the proposal received, and on the same terms and conditions of the contract currently in force;

That the cost of installation and rental of these eight (8) new spaces does not exceed \$ 5,400 excluding taxes;

8. Recreation and Culture

8.1 <u>Parc</u>

Councillor Bruce MacNab explains that the proposed park for residents is moving forward. It will be located on the property of the Jesuits and include platforms whose configuration is currently under analysis.

Mayor Luc Trépanier adds that currently, no additional parking space is planned.

Councillor Jean Dubois also specifies that the addition of docks is primarily to allow or greater sun access.

9. R.C.M. and Government affairs

9.1 Resolution 2012-23 - Support to the RCM of Antoine Labelle against the claim of Laurentian wood by forestry companies of Outaouais

Considering that forestry companies of Outaouais request the purchase of an additional allocation of softwood from the Laurentians to the detriment of local businesses;

Whereas it is essential that the natural resources of the Laurentians are exploited, developed and optimized by local businesses to keep jobs and to ensure land use and sustainability of the resource;

Therefore, Councillor Bruce MacNab moved, Councillor Jean Dubois seconded, and it was unanimously resolved by all present:

That the Town of Barkmere support the initiatives taken by the RCM Antoine-Labelle to strongly oppose to the supply request of forestry companies of Outaouais from the Upper Laurentians;

That the Town of Barkmere ask the Government of Quebec and its Minister of Natural Resources and Wildlife to provide adequate supplies to sawmills of the Upper Laurentians to ensure their sustainability.

ADOPTED

9.2 Resolution 2012-24 – Designation of the municipal officer under the Agreement related to the management of complaints under the contract for collect and transport of residual wastes

Considering resolution 2011-94 and the acceptance by the Town of Barkmere of the Agreement related to the management of complaints under the contract for collect and transport of residual wastes;

Considering that section 2.1 of said Agreement require that the municipality provides the services of an employee designated "municipal officer" with the RCM of Laurentides;

Whereas it is required to officially designate this officer with the RCM of Laurentides;

Therefore, Councillor Bruce MacNab moved, Councillor Jean Dubois seconded, and it was unanimously resolved by all present:

That the Town of Barkmere means the director general as the "municipal officer" with the RCM of Laurentides in accordance with section 2.1 of Agreement related to the management of complaints under the contract for collect and transport of residual wastes;
