## 3. Current Affairs

## 3.1. Announcements

Mayor Luc Trépanier reports that Richard Hartley found a swimming raft / floating dock he brought to his residence. Notice to the owner to contact Mr. Hartley to recover.

Also, a public meeting will be held on July 13, following various notices of motion and the draft by-laws to be adopted at the meeting in June.

The owner of Access Group contacted the mayor to inform that a signal repeater was finally installed, enabling sectors of Patry, Silver and Wentworth Bays and the Duncan Road to be served by the high speed internet signal. Only certain portions of Green Bay, Reeve's Bay and the Narrows are still not served. They could possibly be covered in the coming months.

## 3.2. Correspondence

Letter from Ian McDiarmid regarding the safety issue at the rental docks where several thefts occurred last year. He suggested to put a safety fence or cameras.

## 5. Urbanism

# 5.1. Notice of motion - Boathouses

Councillor Stephen Lloyd gives a notice of motion to introduce at a next meeting, a draft bylaw to amend the zoning bylaw. This draft bylaw aims to restrict construction standards of boathouses, especially height, as well as identify the types of materials allowed for construction and floating for docks and boathouses.

## 5.2. Notice of motion - Winter temporary shelters

Councillor Stephen Lloyd gives a notice of motion to introduce a bylaw to amend the zoning bylaw 201, to change the rules and conditions for setting up temporary winter shelters.

# 6.1. Water quality

Councillor Jake Chadwick files the water quality report of the Consultative Committee for the Environment. This report describes the various tests done in the lake, tributaries and the creek in the past year. The results show that the lake is healthy. The report also outlines the actions that will be taken this year. It will be available on the Town's website shortly.

## 7. Public services

## 7.1. Infrastructures

## 7.1.1. <u>Dam</u>

Councillor Laurent Barbé reported on the latest developments regarding the dam. According to the letter received from MAMROT, it was found that the rehabilitation project was ultimately not eligible for the subsidy.

The Centre hydrique has been contacted. Considering that nearly 500 dams in Quebec are in a similar situation, either taken with repairs but lack of funds, the Town must provide a technical report prepared by engineers demonstrating the absence of major risks to allow the postponement of repairs. A request will be made to postpone the work for another two (2) years.

Meanwhile, the Town will establish a financial reserve to provide funding for this work, lack of funding available.

Mayor Luc Trépanier added that the coveted grant could be used to improve municipal buildings, including Town Hall and the Community Center, which are in unsanitary conditions. It will be possible for the inspector, who was trained as a draftman, to design a plan and submit a project.

## 7.2. Landing

## 7.2.1. Resolution 2013-44 – Lease on the lot 2-44-3, range 6, Township of Arundel

**Whereas** lot 2-44-3, Range 6, Township of Arundel, Argenteuil division belonging to the Town of Barkmere;

**Considering that** the Town wants to use this land for rental mooring spaces for residents of the Town of Barkmere only.

**Whereas** some of this land is already occupied by two (2) docks originally built by request of the Town Council, and have been used for the rental of mooring spaces.

**Considering** the request received from Delia Miller.

**Therefore**, Councillor Stephen Lloyd moved, Councillor Laurent Barbé seconded, and it was unanimously resolved by all present:

**That** the Town of Barkmere lease to Delia Miller part of the said land at the following conditions:

-for the implementation and use of two (2) docks only;

-10-year term renewable

-\$150 per year;

-rental mooring spaces are reserved for residents of Barkmere only and for non-commercial purposes;

That the Mayor and Director general be authorized to sign the lease;

## 8. <u>Recreation and culture</u>

Councillor Bruce MacNab informed of the official opening of the park scheduled June 29. There is only some work left to do, including the installation of the platform, the sign, the picnic table, etc.

## 9. Legal affairs

## 9.1. Resolution 2013-45 – Land Survey contract

**Considering** the road built on lot 13-9, range 5, 12P and 13P, range 5, and lots 12P and 13P range 6, cadastre of Township of Montcalm, division of Argenteuil;

**Considering** the need to precisely locate this road;

**Considering** sections 573.1 and 573.3.0.2 of the Cities and Towns Act (L.R.Q. c. C-19) and the Regulation respecting the awarding of contracts for certain professional services;

**Therefore**, Councillor Bruce MacNab moved, Councillor Jean Dubois seconded, and it was unanimously resolved by all present:

**That** the Town of Barkmere mandate the firm Barbe et Robidoux, land surveyors, to locate the said road and provide a plan;

That the fees do not exceed \$2,200 taxes not included;
