2. Adoption of the minutes

2.1 <u>Resolution 2016-095– Adoption of the minutes of the regular meeting held on</u> <u>September 10th 2016</u>

Recognizing that all the members of this meeting received a copy of the minutes at least 24 prior to this meeting according to provisions of the article 333 of the *Cities and Towns Act* (R.S.Q. c.C-19)

THEREFORE, it is proposed by Councillor Bruce Macnab, and seconded by Councillor Stephen Lloyd, and it is adopted unanimously by the present members:

3. Current Affairs

3.1 Announcements

The new municipal building is almost completed. We fully respect the planned budget, no additional cost is foreseen. We are slightly behind in the completion of the new Municipal Building. Three main reasons: changes were made to the exterior staircase; the color of the arborite for the counters was discontinued which delayed their construction and consequently the plumbing. Also, the wood for the ceiling of the community hall arrived late. However, we hope to be able to hold the next city council in the building.

3.2 Correspondences

We received two correspondences, one confirming the \$ 30,000 grant from the Department of Transportation, Sustainable Mobility and Transportation Electrification and the other from the Department of Municipal Affairs and Land Occupancy confirming The publication of the coming into force of the regulation amending the regulation ordering the imposition of a tax for the financing of 9-1-1 emergency centers.

3.3 <u>BLPA</u>

No representatives were present.

3.4 Follow up from last meeting

In follow up to the question of Ms Suzanne Sylvestre on garbage bins with a lock mechanism, Mayor Trépanier raised the question with the person in charge of waste management at the MRC. She mentioned that it was possible to have a tender to that effect, if there was a sufficient volume of request to make it worth it. However, these bins are not very popular with the companies that do the garbage collection, as it happens often that people forget to unlock them before the truck passes.

3.5 Question Period (30 minutes)

Mrs Susan De Schulthess: What happens with Filau?

Last June the filament servers were infected with a computer virus. The Board of Directors has hired a subcontractor to manage the technical management. As a result, Filau was mismanaged. The project to install antennas in Barkmere is postponed to 2017.

4.4 Resolution 2016-098 – Appointment of a Pro-Mayor

WHEREAS the Town of Barkmere must ensure its functioning and its representation in case the Mayor is absent;

WHEREAS article 56 of the Cities and Towns Act (R.S.Q. c.C-19) allows the Town Council to designate a Councillor to act as pro-mayor for a fixed period;

WHEREAS the mandate of Councillor Marc Fredette as Pro-Mayor of the Town of Barkmere ends on October 8th, 2016;

THEREFORE, Councillor Jake Chadwick moved, Councillor Chantal Raymond seconded, and it was unanimously resolved by all present:

THAT Councillor Tim Kalil be appointed as Pro-Mayor of the Town of Barkmere for the period starting October 9th, 2016 and ending January 14th, 2017 inclusively.

5.2 <u>RESOLUTION 2016-099 – Grant of contract for the networking cabling of the Town</u> <u>Hall and the Community Centre</u>

CONSIDERING the resolution 2016-054;

CONSIDERING THAT the town must proceed to the installation of the networking cabling in the new building :

THEREFORE, Councillor Stephen Lloyd moved, Councillor Bruce MacNab seconded, and it was unanimously resolved by all present:

TO ACCEPT the quote received by the company Laurentides Télécommunication for a total cost of \$1,254.67 plus applicable taxes for the installation of the network cables in the new Town Hall and Community Centre of the Town of Barkmere.

AND

THAT the sum be paid with the surplus allocated to the municipal building project.

ADOPTED

5.3 <u>RESOLUTION 2016-100 – Grant of a contract for the construction of a</u> <u>decontamination ramp</u>

CONSIDERING the presence of Asian milfoil in Bark Lake ;

CONSIDERING THAT the Town proceeds to the decontamination of boats accessing to Bark Lake without installations that would ensure an adequate washing;

CONSIDERING THAT the Town must ensure that the decontamination of boats is done in a way that will reduce the risk of infestation of native species by boats to nothing;

THEREFORE, Councillor Stephen Lloyd moved, Councillor Jake Chadwick seconded, and it was unanimously resolved by all present:

TO ACCEPT the quote from Gilbert P. Miller & Fils Ltée and to proceed with the work, for a maximum of \$6,550.00 plus applicable taxes to build a decontamination ramp adjacent to the municipal garage.

AND

THAT the sums be taken from the unallocated surplus of the Town.

5.4 <u>RESOLUTION 2016-101 – Grant of a contract for work improvements and road</u> protection at the landing

CONSIDERING THAT the Town has received a grant of \$30,000 under the "Programme d'aide à l'amélioration du réseau routier municipal";

CONSIDERING THAT the Town has received a quote from Gilbert P. Miller & Fils Ltée on September 5th, 2016 for improvements and repairs of the landing road;

THEREFORE, Councillor Bruce MacNab moved, Councillor Jake Chadwick seconded, and it was unanimously resolved by all present:

TO ACCEPT the quote from Gilbert P. Miller & Fils Ltée and to proceed with the work for a total amount of \$17,995. 00 plus applicable taxes.

TO ACCEPT the quote from Gilbert P. Miller & Fils Ltée and to proceed with the work for a total amount of \$3,850.00 plus applicable taxes.

5.6 <u>RESOLUTION 2016-103– Grant of a contract for the installation of a garage door at</u> <u>the old Community Centre</u>

CONSIDERING the resolution 2016-054;

CONSIDERING THAT the Town will no longer use the building that was housing the Community Center for that end;

CONSIDERING THAT the Municipal Council wishes to transform this building into a municipal garage;

THEREFORE, Councillor Chantal Raymond moved, Councillor Bruce MacNab seconded, and it was unanimously resolved by all present:

TO ACCEPT the quote from Portes de garages des Laurentides for a total amount \$1,893.16 plus applicable taxes for the installation of a garage door.

AND

THAT the sums be taken from the unallocated surplus of the Town.

5.7 <u>RESOLUTION 2016-104 – Grant of a contract for electrical work at the old</u> <u>Community Center</u>

CONSIDERING THAT the Municipal Council wishes to transform this building into a municipal garage;

THEREFORE, Councillor Stephen Lloyd moved, Councillor Chantal Raymond seconded, and it was unanimously resolved by all present:

TO ACCEPT the quote from Les Entreprises d'Électricité Lumitech for a total cost of \$4 768.00 plus applicable taxes for the execution of various electrical works required for the new municipal garage.

AND

THAT the sums be taken from the unallocated surplus of the Town.

ADOPTED

5.8 <u>RESOLUTION 2016-105 – Grant of a contract for the demolition of the old Town</u> <u>Hall</u>

CONSIDERING the resolution 2016-054;

CONSIDERING THAT the Town will no longer use the old Town Hall for its administration;

CONSIDERING THAT the old Town Hall is was deemed beyond repair and was shut down due to the presence of asbestos in the insulation ;

THEREFORE, Councillor Bruce MacNab moved, Councillor Jake Chadwick seconded, and it was unanimously resolved by all present:

TO ACCEPT the quote from Gilbert P. Miller & Fils Ltée and to proceed to the demolition for a total amount of \$3,300.00 plus applicable taxes.

AND

THAT the sums be taken from the unallocated surplus of the Town.

ADOPTED

5.9 <u>RESOLUTION 2016-106– Grant of a contract for asbestos removal from the old</u> <u>Town Hall</u>

CONSIDERING the resolution 2016-054;

CONSIDERING THAT the Town will no longer use the old Town Hall for its administration;

CONSIDERING THAT the old Town Hall is was deemed beyond repair and was shut down due to the presence of asbestos in the insulation;

THEREFORE, Councillor Stephen Lloyd moved, Councillor Bruce MacNab seconded, and it was unanimously resolved by all present:

TO ACCEPT the quote from ServiceMaster Laurentides and to proceed to the removal of asbestos before demolition for a maximum of \$4,325.00 plus applicable taxes.

AND

THAT the sums be taken from the unallocated surplus of the Town.

ADOPTED

5.10 <u>RESOLUTION 2016-107– Allocation of a part of the Parks and Playgrounds Fund</u> for the installation of outdoor fitness games

CONSIDERING THAT Goulden Island was bequeathed to the Town of Barkmere by the will of the late Christopher Healy Goulden and the deed from his widow Adelaide Mackenzie Mae and her daughter Edith M. Goulden, provided it is used as a park or recreation ground for all citizens and residents of Barkmere;

CONSIDERING THAT the Municipal Council wishes to proceed to the installation of outdoor fitness games on the Golden Island.

THEREFORE, Councillor Chantal Raymond moved, Councillor Bruce MacNab seconded, and it was unanimously resolved by all present:

THAT the Town of Barkmere allocate \$8,000 from the Parks and Playgrounds Fund for the installation of outdoor fitness games on Goulden Island.

ADOPTED

5.11 <u>RESOLUTION 2016-108– Grant of a contract for a study on the stability of dikes on</u> the dam of Bark Lake

CONSIDERING THAT the Town of Barkmere owns the Bark Lake dam, and consequently must maintain and ensure the permanence of the dam in compliance with the Dam Safety Act (C.Q.L.R. c. S-3.1.01) and the Watercourses Act (C.Q.L.R. c. R-13);

CONSIDERING THAT the dam was repaired and consolidated in November 2015;

CONSIDERING THAT the last step required in order to obtain the reclassification of the dam is to proceed with a study on the stability of the dikes;

CONSIDERING sections 573.1 and 573.3.0.2 of the Cities and Towns Act (R.S.Q., chap. C-19) and the Regulation respecting the awarding of contracts for certain professional services;

THEREFORE, Councillor Stephen Lloyd moved, Councillor Bruce MacNab seconded, and it was unanimously resolved by all present:

THAT the firm Donovan Experts Conseils be mandated to evaluate the stability of dams as described in the offer of services S-GEO-16 740

THAT the amount of the contract be \$3,900.00 plus applicable taxes;

THAT the sums be taken from the surplus of the Town allocated to the rehabilitation of the dam.

ADOPTED

6. Urban Planning

6.1 <u>RESOLUTION 2016-109 – Approval of Plans Pursuant to By-Law No. 206 - Architectural</u> Installation and Integration Plan (PIIA)

WHEREAS the construction of a two storey residential building located on a vacant lot (the Gareau property), being lot 1-5 of range 6, situated on Priests' Point, is subject to review under Architectural Installation and Integration Plan (PIIA) by-law #206;

WHEREAS the project was studied by the Consultative Committee on Urbanism (CCU), at its meeting on August 27, 2016, in accordance with the criteria set forth in the Architectural Installation and Integration Plan (PIIA) by-law #206;

WHEREAS the CCU unanimously supports the project, all while proposing certain additional suggestions;

WHEREAS the Municipal Council of the Town of Barkmere has reviewed the additional suggestions of the CCU;

THEREFOR, Councillor Stephen Lloyd moved, Councillor Chantal Raymond seconded, and it was unanimously resolved by all present:

THAT the Municipal Council of the Town of Barkmere approve the plans and documents submitted under the Architectural Installation and Integration Plan (PIIA) by-law #206 for the proposed construction on a vacant lot (the Gareau property), being lot 1-5 of range 6, situated on Priests' Point;

THAT the building inspector issue the permit related to the review of the project pursuant to the Architectural Installation and Integration Plan (PIIA) by-law #206, all while taking into consideration the following additional suggestions:

- ensuring a rigorous control over: (a) any erosion occurring during the construction works, notably by way of a geotextile membrane; and (b) a prohibition against any cutting of trees in the area between the building and the Lake; and
- ii. ensuring that any exterior lighting associated with the building is strictly in conformity with Zoning by-law law #201.

THAT the issuance of any subsequent permit for a garage or driveway for the project be subject to the condition that the "functional vehicular access" which links the project to Priests' Road be regularized in order to be brought into conformity with the applicable urban planning by-laws of the Town of Barkmere.

ADOPTED

6.2 NOTICE OF MOTION – Modification of Bylaw 201

A notice of motion is given by Councillor Stephen Lloyd, to introduce at a future meeting of the Council a bylaw amending Zoning Bylaw 201 to revise the acquired rights ("grandfather rights") applicable to non-conforming road constructions, in order to ensure the security of citizens and the protection of the environment.

ADOPTED

7. M.R.C and governmental affairs

7.1 Mayor's report

During the pre-meeting of the last Mayors Council, Hydro-Quebec made a presentation on the electrification of transports and the Electrical Circuit. There are 3 types of charging terminals, one that charges fast, which is used to "fill up" but is very expensive, one that charges slowly, less expensive, but it can only used to "top up". There are also terminal for internal use only, as for a Town that would have a fleet of electrical vehicles. The problem with a public terminal, is that they are publicized, and that we would have visitors... One thing is sure: the electrification of cars will happen, but we need to think if we want to have a charging terminal in Barkmere.

On another subject, the Mayors Council accepted that Barkmere finances the move of the fibre optic within the Pacte Rural program, instead of the new community centre.
