



## **Boat Identification Label Procurement Procedure**

*Implementation of by-law 243 for the identification of boats with an identification label*

### ***Identification label and mandatory decontamination at Lac des Écorces***

***Note - In order to speed up the process of obtaining an identification label, please fill out your form before your arrival in Barkmere and do not forget your supporting documents.***

#### **What type of boat should be provided with an identification label:**

Every motorized vessel on or intended to be on the Lake must have an identification label and any non-motorized vessel on or intended to be on the Lake that is not owned by a resident must be equipped with an identification label.

#### **What is an identification label:**

A self-adhesive label or daily pass issued by the Town bearing the Town logo, intended to be affixed visibly to a boat, on which appears the year, season or period for which the identification label is in effect.

#### **How do I get an identification label:**

To obtain an identification label for a boat, the owner of the boat must complete and sign the registration form provided by the Town: available on the Town website, at the Town Hall or at the decontamination station. FormVignetteAng.PDF

*For an owner of property in the Town of Barkmere (you have until October 1, 2017 to obtain your identification label):*

You will need: your contact information, a piece of identification, proof of property ownership in Barkmere, technical data of your boat (model, length, motor horse power) and your pleasure craft license that proves that you own the boat. *For a non-owner of property in the Town of Barkmere:*

If you are a tenant/renter in the Town of Barkmere

You will need: your contact information, a piece of identification, your rental agreement (*signed by the parties*) in the Town of Barkmere, technical data of your boat (model, length, motor horse power) and your pleasure craft license which proves that you are the owner of the boat. In other cases :

Once the registration procedure has been completed, you must be present during the opening hours at the decontamination station located at 194 chemin Barkmere in Barkmere with your completed form and the documents requested so that an employee can finalize your file and proceed to installing your identification label on your boat. If you plan to go to the lake after your identification label has been issued please allow for about 15 minutes so that we can decontaminate your boat.

### **Duration and cost of the identification label**

**For property owners in the Town of Barkmere**, the identification label is valid as long as you own the boat and you own the property in the Town of Barkmere. The identification label is free of charge.

**For renters in the Town of Barkmere**, the duration of the identification label is valid only for the rental period without exceeding October 15 of the year of issue of the sticker and you own the boat. For the cost of the identification label see file PriceVignette2017En.PDF *The price includes the decontamination as well as the parking.*

**For visitors** (staying with property owners **in the Town of Barkmere**), the identification label is valid only for a period of 7 consecutive days and you own the boat and your boat is moored at the dock that you will be visiting. For the cost of the identification label see file PriceVignette2017En.PDF *The price includes the decontamination as well as the parking.*

**For seasonal users** (***your boat must be removed from the lake every day after its launch in accordance with the opening hours***), the identification label is valid for the season without exceeding the October 15 of the year of issuance and you continue to own the boat. For the cost of the identification label see file PriceVignette2017En.PDF *The price includes the decontamination as well as the parking.*

**For daily users** (***your boat must be removed from the lake the same day as its launch according to the opening hours***), the duration of the identification label is valid only for one day. For the cost of the identification label see file PriceVignette2017En.PDF *The price includes the decontamination as well as the parking.*
