<u>4.2 RESOLUTION No. 2018-122 - ADOPTION OF BY-LAW 253 - Financial</u> reserve – Chemin des Jésuites

WHEREAS article 569.1 of the Cities and Towns Act (R.S.Q. c.C-19) authorizes the Town of Barkmere to create financial reserves for the specific purposes of financing the expenses of a specific sector;

WHEREAS the maintenance of Chemin des Jésuites must be entirely paid for by the property owners whose property is made accessible by Priests Road, without any additional costs to the other taxpayers of the Town of Barkmere;

WHEREAS the special taxes collected for the maintenance of Chemin des Jésuites must be used for this sole purpose, and should not be part of the general fund of the Town;

WHEREAS the Urban Plan of the Town of Barkmere set as an objective to attenuate the impacts on the environment of road access to shoreline properties;

WHEREAS a notice of motion was given during the meeting of the Municipal Council on October 13th, 2018 and the draft bylaw was presented;

It is proposed by Councillor Marc-Olivier Duchesne, seconded by Councillor Marc Frédette and it is resolved unanimously by the members present:

THAT the The Municipal Council of the Town of Barkmere adopts bylaw 253 on the creation of a financial reserve for the maintenance and repair expenses of Chemin des Jésuites:

Article 1 – Preamble

The preamble shall be an integral part of the present bylaw.

Article 2 – Financial Reserve

This bylaw creates a financial reserve for a specific sector of the Town of Barkmere, in accordance with article 569.1 of the Cities and Towns Act (R.S.Q. c.C-19).

Article 3 – Abrogations

This bylaw repeals and replaces bylaw 79 " to order the maintenance work on Chemin des Jésuites situated within the limits of the town of Barkmere and to impose a special tax for that purpose on the taxpayers of the town of Barkmere served by this road "and all its amendments"

Article 4 – Prescribed Sector

For the purpose of this bylaw, the name "Chemin des Jésuites" refers to Chemin des Jésuites located on one or more lots belonging to the Town of Barkmere and linked to the municipal landing and parking sector; the western extremity of the road being located at its intersection with the road of the main landing.

The sector of the Town concerned by the financial reserve is constituted by all taxable immovables situated adjacent to the road allowance of Chemin des Jésuites, and those properties whose owner has a right of way, granting access, vehicular or otherwise, direct or through other properties, to Chemin des Jésuites.

Article 5 – Name of the Reserve

The financial reserve created by this bylaw is named "Financial Reserve for the Maintenance and Repairs of Priests Road", for the purposes of financial statement presentation Chemin des Jésuites

Article 6 – Objectives of the Reserve

The financial reserve is to be used for the sole purpose of paying for the direct or indirect expenses, claims, losses or damages related to the maintenance of Chemin des Jésuites, together with upgrades necessary to make the street conform with municipal, provincial or federal laws and regulations, and notably to attenuate the environmental impact of the street.

Article 7 – Projected Amount

The financial reserve is used for the funding of recurring annual expenses, and for the funding of necessary upgrades, and consequently does not have a specific projected amount.

Article 8 – Means of Funding

The financial reserve is funded by means of a special tax levied annually on all immovables described in article 4 of the present bylaw, following a recommendation from the consultative committee defined in article 11 of the present bylaw.

The Municipal Council may allocate to the financial reserve any grant or part of a grant used specifically for the financing of works on Chemin des Jésuites Road.

Article 9 – Duration of Existence

The reserve does not have a fixed duration, and remains in place as long as Chemin des Jésuites remains in existence entirely or in part within the location defined in article 4 of the present bylaw, or until Council repeals the present bylaw.

Article 10 – Allocation of Surpluses

At the end of the existence of the reserve, as specified in article 9 of the present bylaw, any excess of revenues, realized or receivable, over the expenses, realized or incurred, shall be transferred to the general fund of the Town.

Article 11 – Consultative Committee

The present bylaw hereby creates a consultative committee composed of the Mayor of the Town, another member of the Council, and three (3) owners of the immovables described in article 4 of this bylaw and named by the Council for a mandate of four (4) years.

The mandate of the committee is to recommend to the Council the list of regular maintenance works and of necessary upgrades to be carried out, in order for the Council to establish the amount of the special tax described in article 8 of the present bylaw.

Article 12 – Coming into effect

This bylaw comes into effect in conformity with the law.

7.2 <u>Resolution No. 2018-124 – Snow removal 2018-2019 for the City Hall and Chemin</u> <u>des Jésuites</u>

CONSIDERING the offer received from *Gilbert Miller et Fils Ltée* for the snow removal and sanding contract for the Village and for Jesuits Road for the 2016-2017 season;

THEREFORE, Councillor Marc-Olivier Duchesne moved, Councillor Andrea Leber seconded, and it was unanimously resolved by all present:

THAT the snow removal and sanding contract for the 2018-2019 season be awarded to *Gilbert Miller et Fils Ltée*;

THAT the contract includes the following terms and conditions:

- A) Snow removal and sanding of:
 - Jesuits Road;
 - Barkmere Road around the municipal parking;
 - Town Hall and municipal garage centre service areas;
- B) Presentation by the contractor of a proof of civil liability insurance;

THAT the amount of the contract is \$5 000.00 (1 600\$ for chemin des Jésuites and 3 400\$ for the City Hall space) plus applicable taxes, and be paid in 2 installments: January 2nd, 2019 and May 2nd, 2019;

AND

THAT the Mayor and the Director General be authorized to sign a contract for snow removal that meets the terms and conditions of this resolution and the description of work submitted for contractor bids.

CONSIDERING Bylaw 212 which created a financial reserve for the maintenance expenses of Duncan Road;

WHEREAS the offer received from *Gilbert Miller et Fils Ltée* for the snow removal and sanding contract of Duncan Road for the 2018-2019 season;

THEREFORE, Councillor Jake Michael Chadwick moved, Councillor Stephen Lloyd seconded, and it was unanimously resolved by all present:

THAT the snow removal and sanding contract for the 2018-2019 season be awarded to *Gilbert Miller et fils Ltée*;

THAT the contract includes the following terms and conditions:

A) Snow removal and sanding of Duncan Road East, West and North;

B) Presentation by the contractor of a proof of civil liability insurance;

THAT the amount of the contract is \$ 8 10.00 plus the applicable taxes and be paid in two (2) installments: January 2nd, 2019 and May 2nd, 2019;

AND

THAT the Mayor and the Director General be authorized to sign a contract for snow removal that meets the terms and conditions of this resolution and the description of work submitted for contractor bids.

WHEREAS pursuant to resolution 2018.06.7542, the council members of the MRC des Laurentides have shown their interest in carrying out such a study;

WHEREAS the municipality wishes to grant the mandate to the MRC des Laurentides, which will take the necessary steps to carry out a study detailing the various possible scenarios regarding the sharing of equipment, infrastructure and municipal services;

THEREFORE, Councillor Stephen Lloyd moved, Councillor Marc-Olivier Duchesne seconded, and it was unanimously resolved by all present:

THAT the Town of Barkmere ask the MRC des Laurentides, through its director general and secretary-treasurer to deposit and sign, for and on behalf of the municipalities and the MRC des Laurentides, all documents required for filing an application grant under the Program Partage d'infrastructures sportives et de loisirs of ministère des Affaires municipales et de l'Habitation (MAMH);

THAT the Town of Barkmere authorize the MRC des Laurentides to carry out a study on equipment, infrastructures, services or activities pooling in the municipal environment by an external specialist and to make, where appropriate, a call invitations.
