

PUBLIC NOTICE TO INTERESTED PERSONS HAVING THE RIGHT TO SIGN A REQUEST TO PARTICIPATE IN A REFERENDUM

Second draft by-law number 268 modifying by-law number 201 on zoning. PUBLIC NOTICE is given of the following:

1. ADOPTION OF A SECOND DRAFT

Following the public consultation held August 13, 2022 on draft by-law number 268, the municipal council adopted, on August 13, 2022, a second draft by-law bearing number 268 amending by-law number 201 on zoning with the aim of to include provisions relating to short-term rental on the territory of the town of Barkmere.

2. PROVISIONS OF THE DRAFT BY-LAW THAT MAY BE THE SUBJECT OF A REQUEST TO PARTICIPATE IN A REFERENDUM

This second draft by-law contains provisions that are specific to a by-law subject to referendum approval applicable to the entire territory that may be the subject of a request from interested persons qualified to vote in accordance with the Elections Act and referendums in municipalities (LERM).

Article 4 of the draft regulation affects zones Ru-01, Ru-02, NV-01, NV-02 and NV-03 and aims to add references to the specification grids affecting these zones.

3. IDENTIFICATION OF PERSONS WHO HAVE THE RIGHT TO MAKE A REQUEST

Information to determine which interested persons have the right to sign an application with respect to each of the provisions of the project can be obtained at the town hall, located at 199, chemin Barkmere, in Barkmere, during office hours., i.e. Monday to Friday from 8 am to 12 pm and from 1 pm to 4:30 pm.

4. CONDITIONS OF VALIDITY OF A REQUEST

A "person interested", by a provision likely to be approved by referendum, must, if he wishes that this provision be submitted to the approval of qualified voters, sign a request.

To be valid, a request must meet the following conditions:

- 1° clearly indicate the provision to which it relates and the zone from which it originates;
- 2° be signed by at least 20 people from all over the city;
- 3° be received no later than August 25, 2022, at 4:30 p.m.:

5. NO REQUEST

All the provisions of the second draft that have not been the subject of any valid request may be included in a by-law that will not have to be approved by qualified voters.

6. CONSULTATION OF THE PROJECT

7. DESCRIPTION OF TARGETED AREAS

This draft by-law concerns the entire territory of the municipality with regard to provisions 1, 2, 3 and 5.

The article 4 concerns zones Ru-01, Ru-02, Nv-01, Nv-02 and Nv-03. The description of these zones is illustrated on the zoning plan <u>attached</u> to this notice and the zones concerned are hatched in blue.
